- On August 1, 2012, the U.S. Bankruptcy Court for the Middle District of Tennessee made the submission of evidence electronically mandatory for all evidence used in trial, hearing, or at the motion docket.
- Electronic evidence must be submitted using the "Electronic Evidence Submission Application," known as "EESA".
- The EESA application is accessed through CM/ECF.
- In conjunction with EESA, the Court approved procedures known as "E-Evidence Procedures" (cited as "EEP").

Things to Know

- EESA is intended to be intuitive for those accustomed to using the paperless, filing system known as CM/ECF.
- Similar to loading documents for filing to CM/ECF, the EESA application will require that nearly all documentary evidence be converted to one of the allowable formats indicated in EEP.
- EESA will prompt the user to "Browse" for the exhibit(s) and attach them.
- Make sure all exhibits are converted and saved on your computer or laptop with proper naming conventions observed before submitting those exhibits.
- PLEASE make sure to read the EEP as the procedures indicate how documents should be named before submitting any electronic exhibits. Failure to use correct naming conventions <u>will</u> give you an error message and not allow you to continue and submit exhibits.

General Information



3.1 Court Authorized Electronic Evidence Formats

All electronic evidence must be submitted in one of the following allowable formats:

- PDF
- PNG, GIF, JPG/JPEG
- WMV
- MP3
- PPT/PPTX
- EXCEL (in very limited circumstances)

Any of the allowable formats can be compressed into a ZIP file as long as the ZIP file does not exceed the ECF limits. See, § 3.2.

Current recommended maximum individual PDF Size:

35 MB

No Password protection/restriction can be on the file.

Current maximum Merge Document Size:

50 MB

No Password protection/restriction can be on the zip file.

Sharing Filing Accounts

Users should not be sharing ECF account information, i.e. a paralegal using their attorney's log in credentials. When multiple people use the same login credentials on different computers, the "cookies" used by EESA are not always where the system thinks they are and this can cause errors during EESA submission.

To clear your internet browser cache, normally the command of control+shift+delete can be used.

This is not only good practice for EESA, but for CM/ECF and PACER in general.

Avoiding Common Errors



Zipping Folders

When submitting multiple PDFs, zipping them together in a .zip file is the easiest/fastest way to get them into the system. However, each file must be in the .zip file as an individual file and not "nested" inside of folders, see below:

Zipping Folders (continued)

The below group of files would be able to be zipped into a .zip file and be accepted by the system as there are no folders and each individual file uses the correct naming conventions pursuant to EEP.

Avoiding Common Errors



Improperly Named Files

Files must be properly named to be accepted by EESA. The full EESA rules and examples are contained in the <u>EEP</u> in Section 4.3.2 Numbering Exhibits.

The next page will give you a summary of the rule, but parties should take the time to familiarize themselves with the full EEP.

Password Protected or Restricted Files

Files must not be password protected or otherwise "restricted." Check your files before attempting to upload. Oftentimes documents downloaded directly from State Court dockets are restricted and will not upload properly.

Naming Conventions Nutshell

Naming Requirements for Exhibits: The Movant's files must begin with "1001." and the Respondent's must begin with "2001." The file name should describe the contents of the PDF. <u>Please note the period directly after the number is required</u>.

A file name of "1007 contract.pdf" <u>will</u> generate an error.

A file name of "1007.contract.pdf" should not.

Good Examples:

Plaintiff/Movant: 1001.Petition.pdf or 1002.Amended Schedule C.pdf Defendant/Respondent: 2001.Original Title for 2014-truck.pdf or 2002.HOA_doc-Riverbend.pdf

UPPPERCASE, lowercase, 12345, p.e.r.i.o.d.s, s p a c e s, h-y-p-e-n-s, and un_der_scores are all OK. NO SYMBOLS ALLOWED! \$^#@%()

Problematic File Name Examples:

File name	Problem
1001 Truck Title.pdf	No period after the number
Commercial Lease.pdf	No number at the beginning of the file name
1002.Creditor's MFR.pdf	Contains a symbol (apostrophe)
1007.January 5th Deposition.doc	.doc files are not a supported file type
1008.Claim for \$32,000.00.pdf	Contains a symbol (Dollar Sign)
1010.h7hklnsfiudb5238n.pdf	This WILL be accepted by EESA, however the file name does not describe the contents of the file.
