Link Your PACER and CM/ECF Account

Once TNMB implements NextGen, you must link your existing CM/ECF account to your **Individual PACER account** to access the TNMB CM/ECF system. **If your Individual PACER account was created prior to August 2014, you must first upgrade your account** (see [Upgrading Your Individual PACER Account for instructions](#)). If you don't have your own Individual PACER account, [click here to get one now](#).

Linking Your Accounts

Linking is a one-time process that can be completed only once TNMB is Live on NextGen CM/ECF, on or after February 14, 2022.

STEP 1 Go to TNMB's CM/ECF site (<https://ecf.tnmb.uscourts.gov>). Click the **Document Filing System** link.
